

The 2024 high season pickleball schedule begins on January 14, 2024 and runs through the end of April. To determine the number of courts and time slots to allocate to group play we are requesting that all individuals who wish to establish a “Group” to play during the fall season submit a request for courts and times.

Our current parameters allow for one, two or three-court groups to apply for 2 group time slots per week. We are TENTATIVELY TRIALING allowing four-court groups to have 2 time slots per week as well. Our ability to schedule all of the groups and allow any size group to have up to 4 courts twice per week is contingent on the number of group requests we receive. We are still committed to ensuring that we have an adequate percentage of time slots for reservations on demand.

Only HPA-Organized events are currently blocked out on the schedule.

Your request should include the number of courts your group needs, the number of times you’d like to play per week, and what days and times you would like to play. Please include a list of your anticipated group members.

Requesting a group time does not guarantee that your group will receive that time slot, nor does it guarantee that the time or date you request will be available for your group size. It simply enables the scheduling committee to create a schedule that best accommodates all of the group requests. Once we receive the group requests and create a second draft of the preliminary scheduling showing what slots are available for various group size, we will provide details regarding the group play lottery. The full schedule is as follows:

- December 30: Group Requests Due
- January 4: Preliminary schedule published showing available group slots
- January 9: Group Play Lottery
- January 11: Final schedule published with HPA Organized Events and group times
- January 11: Group leaders set up group events in Court Reserve
- January 14: High Season schedule begins

Most group play will be scheduled on courts 1-4. Early morning and evening group play requests may request to play on lighted courts 5-8. The current schedule doesn't reflect the late play times which run through 8:00 PM.
